Grant County intends to apply for CDBG funding in 2020: CDBG-CV1 Public Services Grant Funding.

2020 CDBG-CV1 Public Services Grant Application

It is anticipated that up to \$575,511 (but likely less) will be available to the County and Opportunities Industrialization Center of Washington (OIC of WA) to fund local public services and microenterprise assistance programs; and public health, emergency response, or temporary housing facilities that address COVID-19 impacts, and grant administration.
