The Grant County Commissioners session was called to order at 9:00 a.m. with all the Commissioners in attendance with the Clerk of the Board.

OPEN RECORD PUBLIC HEARING, CORONER, FAIRGROUNDS, AND DISTRICT COURT BUDGET EXTENSIONS

The Commissioners held an Open Record Public Hearing regarding the following budget extension requests:

- Coroner's Office Fund #001, Department #120 in the amount of \$2,500.00 to purchase small tools
- Fairgrounds Fund #126, Department #168 in the amount of \$40,000.00 for ADA Improvements to the Fairgrounds Park
- District Court Fund #001, Department #102 in the amount of \$800.00 for a grant received from the Washington Traffic Safety Commission to start a new drug court

For the record, the Clerk of the Board noted that a budget extension had been advertised for the Sheriff's Office in the amount of \$26,544.00 to purchase a vault toilet for the Moses Lake Sand Dunes. It was determined by the Chief Accountant that this was not necessary. This item can be purchased from the Capital Outlay account, using REET funds.

Commissioner Carter moved to close the public comment portion of the hearing, Commissioner Allison seconded and the motion passed unanimously. Commissioner Allison moved to adopt the budget extensions as presented, Commissioner Carter seconded and the motion passed unanimously. The hearing adjourned. **(Resolution 08-11-CC)**

D NELSON, COMMUNITY DEVELOPMENT UPDATE

The Commissioners approved the request for establishing a Hearing Examiner Pro-Tem. With the recommendation of Andy Kottkamp of the Law firm of Kottkamp & Yedinak, Andy Kottkamp has recommended his partner Nick Yedinak. Nick Yedinak will perform the services of this role under the current contract.
