Madeline Prentice, Chief Accountant, discussed the proposal. They discovered that starting in 2007-2016 the LEOFF 1 employee benefit premiums were not being swept from the Sheriff's Office to the Benefit Fund. Processes are now in place and monies are being swept accordingly.

The Stop Loss reimbursements were being received but misapplied to the current expense fund instead of the Interfund Benefits Fund.
