Commissioner Taylor stated that after discussion, the microphone system funding will be taken from the REET Fund #132, Department #178.

Madeline Prentice, Chief Accountant, recommends the funding for the settlement payment come from the Fairgrounds Sewer Project Fund #309, Department #000.

A motion was made by Commissioner Carter, seconded by Commissioner Stevens to close the public comment portion of the hearing. The motion passed unanimously. Commissioner Stevens moved to approve the budget extensions noting that the funding for the microphone system to come out of the REET 2 Fund #132 and the settlement payment come out of the Fairgrounds Sewer Project Fund #309.
