Policy Directive approval of the Sheriff's Office Uniform Stipend policy and clarified as follows: When a uniform is dictated under the authority of the Sheriff, the purchase cost of the individual uniform pieces will be provided by the department; and the cost of cleaning and repair will be provided by the department. This directive impacts those positions not covered by a collective bargaining agreement. The union-represented positions will be guided by their specific agreement.

Open Record Public Hearing, Ordinance amending Ch. 3.72 of the Grant County Code titled "Sheriff Fees for Official Services"

The Commissioners held an Open Record Public Hearing to consider a fee increase for their Concealed Pistol License (CPL) fee from \$48.00 to \$50.00. This is due to the Federal Bureau of Investigations (FBI) and Washington State Patrol increasing their fees.

Dustin Canfield, Chief Deputy discussed the request.

Open Record Public Hearing, Ordinance Amending Grant County Code Ch. 9.07 titled "Dangerous Dog and Potentially Dangerous Dog"

The Commissioners held an Open Record Public Hearing to consider an Ordinance amending Ch. 9.07 of the Grant County Code titled "Dangerous Dog and Potentially Dangerous Dog".

No one from the Sheriff's Office spoke of the changes so Commissioner Carter relayed that the ordinance amendment will reduce the fines associated with Dangerous Dogs as follows:

- First Offense \$500
- Second Offense \$1000
- Third and subsequent Offense \$2000

This reduction is to allow the state mandated 105% tax that is added to each fine listed above, through District Court.
