- Grants Administration Fund #190, Department #001, for Washington State Department of Commerce Coronavirus Relief Funds (CFR) Grant through CARES Act Grant No. 20-6541C-013, including Amendment A, in the total amount of \$7,405,500.00 for direct Grant County relief and pass-through funding.
